

Conceptual site and building diagrams depict potential building and site relationships. Actual layout and design to be developed.



BOND PROPOSAL FACTS

Looking to the future of Elk Rapids Schools, the Board of Education is asking the community to consider a bond proposal on Tuesday, November 3, 2020, for district-wide improvements to address identified and ongoing building, facility and site issues.

If approved, this bond proposal would generate \$49,995,000 and would focus on district-wide improvements to all school buildings. The bond projects focus on improving safety & security, building & site improvements to aging systems and improving educational spaces, and upgrading educational technology.












MILL CREEK ELEMENTARY SCHOOL PROPOSED IMPROVEMENTS










CHERRYLAND MIDDLE SCHOOL PROPOSED IMPROVEMENTS










ELK RAPIDS HIGH SCHOOL PROPOSED IMPROVEMENTS
